The engagement shall be on the following terms and conditions:

1. That the arrangement is purely on need basis for the academic session 2026;
2. That the engagement shall come to an end by the end of academic session 2026 or till the post (s) is/are filled on substantive basis or as and when the University declares Winter vacations, whichever is earlier;
3. That the engagement shall be purely based on performance/conduct behaviour to be monitored evaluated by the concerned Head of Department periodically;
4. That the emoluments shall be determined on the basis of the qualification (s) possessed as on the cut-off/last date for submission of applications as specified in the Advertisement Notice.

The engagee (s) shall be required to produce the following documents in the Administration-TW:

1. All qualification certificates in original along with self-attested xerox copies.
2. Joining report to be submitted through Head/Director/Coordinator of the concerned Department/Institute;
3. Undertaking to be sworn-in- before the 1st Class Judicial Magistrate to the effect that:

- a) The engagee(s) shall not claim continuation for the next academic session;
- b) The engagee(s) shall not claim absorption/ permanence or regularization against the said engagement;
- c) The engagee (s) shall abide by the directions of the University authorities and maintain discipline in the University;
- d) The engagee(s) shall pave way for a candidate appointed on substantive basis or transferred against the post, as the case may be;
- e) That the certificates/other testimonials submitted by the engagee(s) are genuine and not fabricated and in case it is found, at any stage of the engagement in the University, that the certificate/s or any other record/s submitted by the engagee(s) is not based on facts or has been misrepresented, the contract shall get invalidated leading to the termination from the temporary engagement. Besides, the University reserves a right to take any other action as may be deemed appropriate against him/her.
- f) That the engagee(s) is/are not in employment in any Government or Semi-Government Department or any other Institution, and if found otherwise at any stage, the temporary engagement shall stand terminated without any notice.
- g) That the engagee(s) should submit the undertaking, if satisfied with the terms conditions mentioned in the Advertisement notice/engagement order.

The emoluments in favour of the above engagee (s) shall be paid by debit to the "**Salary Grant**" Budget head of the concerned Department.

This order is issued subject to outcome of the writ petition, if any, pending before the Hon'ble Court of Law.
